PHILANTHROPY IS LOVE OF HUMANKIND

The late **Dr. Vincent Harding**, a Denver treasure and dear friend, often invoked the words of Dr. Martin Luther King, Jr., when speaking to the "beloved community." Today, as I write to WFCO's beloved community, I reach for the spirit of my Black ancestors, such as Sojourner Truth. Truth was born into slavery, where her body was used as property for profit. Truth became a leader of the abolitionist movement. At the 1851 Women's Rights Convention in Akron, Ohio, where some asked that she not be allowed to speak, she asked the audience, **"Ain't I a Woman?"**

Among the cascade of pain, sadness, anger, and hurt that our communities feel today lies a difficult truth. 169 years later, movements for suffrage, LGBTQ+ rights, feminism, reproductive rights, #MeToo, and woke women's marches for justice continue to struggle with what it really means to respond "yes" to Sojourner Truth. When women's outcomes for life itself are pre-determined by their background, what they look like, where they were born or where they live, how they pray, or their abilities, our movements leave many women behind. Equity is authentically shared power and voice. Without racial equity, there cannot be gender equity.

The trauma of COVID-19 only compounds the ongoing, cumulative pain of centuries of oppression. Black and Latinx women and men are more likely to die from complications, we are at greater risk of losing our homes, and our children are most likely to be hungry *and* least likely to have technology for online learning. COVID unflinchingly exposed underlying systemic disparities in health care, education, housing, and child care based on race, class, and yes, gender. To acknowledge these facts is not to deny that the pandemic has affected us all statewide. It is to say that some Coloradans are more likely to lose their livelihoods or their lives simply because of who they are. It is to say Black Lives Matter – a movement founded by women. How do we use the trauma of today, of our history, to create a sustained better-yet-to-come? For WFCO, we commit to continued listening, learning, and growing through shared power and voice. The gender and racial equity we strive for starts with us. Through our history, we haven't always done this well. We believe that philanthropy is not only the sphere of the white and the wealthy. We will continue our racial equity journey through intentional and increased investments in women and girls of color. I'm proud to share that WFCO's executive committee of the board of trustees has approved our exploration of establishing the Women & Girls of Color Fund. Our staff has been working proactively for several months on the creation of a community-led field of interest fund that will invest in women-of-color-led and women-and-girls-of-color-serving organizations across Colorado. More information to come this fall.

Because philanthropy is the love of humankind, we will move forward with our **2020 Annual Luncheon**. I urge you and your beloved community to join us through our House Party format from August 27-30 (see page 3). Donations of every level are critical. Why? Because we are the only community foundation in Colorado focused on women. Our colleagues recognize that only WFCO can bring an intersectional gender-lens expertise to Colorado's recovery. You will see on page 2 that several foundations have not only given relief grants, but funded our ongoing essential research, advocacy, grantmaking, and more.

To create the systemic changes necessary for ALL women and families to thrive, we need your commitment, too. I am proud to stand beside you, addressing a movement of women and men fired up and ready to do more. I hope for a better future, where simply waking in the morning is not a cause for fear because of the color of one's skin. I hope for a better future for the next generation, for my family, for your family, for all Coloradans. Hope is important.

At the start of the pandemic, we immediately converted all of our previously awarded grants to unrestricted funds and gave \$10,000 to the Governor's COVID-19 Relief Fund.

Through our Women and Families of CO Relief Fund (WFCO Relief Fund), seeded by The Colorado Health Foundation, WFCO then made 66 rapid response grants totaling \$452,500 in April to mitigate these inequities. The organizations that received funding respond to a variety of critical needs of Colorado women and families including housing, food, transportation, child care, health care, behavioral health, and reproductive health. They focus on many populations vulnerable to the economic fallout of COVID-19, including women of color, women with disabilities, immigrant and refugee women, domestic violence survivors, women experiencing homelessness, and more.

With additional relief funding arriving from more generous individuals and several foundations in June, including \$50,000 from Rose Community Foundation and an additional \$212,500 grant from The Colorado Health Foundation, WFCO will announce additional grants soon from the WFCO Relief Fund. As of the publication of this newsletter, WFCO has awarded in total:

- 14 general operating grants to our existing WAGES (Women Achieving Greater Economic Security) grantee cohort direct-service partners
- **42 rapid-response grants** to organizations in 17 counties
- Nine grants to women-led social ventures and small businesses
- **One grant** to the Mile High United Way Keep The Lights On Fund, which makes bulk purchases of essential supplies to help child care providers continue operations.

Community First Foundation increased its COVID-19 relief funding to four organizations serving women and families in Jefferson County that applied for grants from the WFCO Relief Fund. Members of our team have also been appointed to Denver Mayor Michael B. Hancock's Economic Relief and Recovery Council, the Metro Denver Chamber's Prosper CO Strike team, and the community voices committee for the Governor's COVID-19 Relief Fund.

Additionally, in partnership with WFCO,

In all, WFCO received 287 applications from organizations in 35 Colorado counties for general operating rapid-response grants.

"The vast number of organizations that applied from more than half of Colorado's counties demonstrates that women and their families in every part of our state are deeply and devastatingly impacted by COVID-19. The needs are most pronounced for women of color and women in rural counties," said Lauren Casteel. "We are particularly proud of the specific relief support we've been able to provide to Colorado women and families who need it most."
