The Women's Impact Investing Giving Circle ("WIIGC")

As a member of WIIGC, you will be helping to drive change through your philanthropy while learning through a hands-on educational process how to invest in impact projects. Members of the WIIGC will experience:

- Hands-on **learning** environment
- Collective giving – Collective investing
- The opportunity to **leverage your charitable dollars** for change
- A greater **understanding of community needs** and services
- **Networking opportunities** with people of shared values
- Income and principal recycled for greater impact

Donors to the Women's Impact Investing Giving Circle by contributing at least \$2,000 to the fund ,are automatically members through March 31, 2020 with the right to one vote, regardless of contribution amount above \$2,000. Membership in the WIIGC entitles members to participate on the Advisory Committee, which will make distribution recommendations to WFCO's Board of Directors. The WFCO Board of Directors and/or the WFCO Programmatic Investment Committee (depending on the size and type of investment as defined and qualified by the Impact Investing Policy Statement) shall have sole authority to approve recommended investments by the WIIGC. Any principal returned, or income earned, at any time from distributions made during your membership are returned to the WIIGC fund for future distribution. Members do not earn income or receive return of principal from this fund.
